

ExeSim Super Saver 4G Mobile Voice Plan (7G17-XS)

This summary gives you the important information you need to know about your Exetel mobile Voice plan. It covers things like the length of your contract, billing, what's covered and what's not.

Information About The Service

This plan offers a \$9.99 4G mobile voice service on a month to month term which includes two included value allowances and two unlimited allowance.

- 1. 300 minutes of National talk to Landlines and Mobiles*
- 2. 1GB of National Data*
- 3. UNLIMITED on-account calls to Exetel Mobile, Fixed & VoIP services and Exetel Sales & Support Numbers
- 4. UNLIMITED National SMS and MMS

Recurring charges are payable monthly in advance. The allowances expire at the end of each month. The included National Data allowance includes all usage for both uploads and downloads. This is a stand-alone service and is not bundled with any other product. * Prorata allowance applies in the first month.

BYO device

A compatible mobile (with the Optus Network) device is required to gain access to the service, and is required to be operated inside the coverage area. Minimum term

Your minimum term is a full calendar month with the option to cancel with 28 days notice.

Included in this offer

The included National talk allowance can be used to make calls in Australia to Australian Fixed lines & Mobile numbers, The Unlimited SMS and MMS allowance can be used in Australia to send SMS and MMS messages to other Australian mobile numbers in Australia. The Unlimited On-Account Allowance can be used to make FREE calls in Australia to all of your Exetel Mobile and Fixed (PSTN & VoIP) Services on the same Account as your ExeSim Saver (7G17-XS) Mobile Service. The unlimited calls to Exetel Sales & Support Numbers allow you to call 02 8030 1000,13 39 38, 1300 788 141 and 1300 393 835 for Free. The included National Data allowance can be used in Australia to access the internet from a compatible device.

What is not included in this offer

The included National talk and SMS/MMS allowance cannot be used for calls and messages that are not specifically mentioned in the included allowances; which includes (but is not limited to); International Calls, Premium Calls to 190X or 0055 services, Premium SMS/MSS to numbers starting with '191', '193 – '197' and '199', Premium/Paid content, content packs, directory assistance or any other content services or charges. The monthly allowances are not interchangeable and unused value from one allowance cannot be transferred to another or into the current or following month if unused. For example, excess National talk & SMS/MMS values cannot be transferred to any unused value in the National Data allowance

Information about pricing

Minimum monthly cost

\$9.99 is the minimum financial commitment for this offer. If your usage exceeds the included National talk allowance, and/or the National Data allowance, additional usage charges apply.

The most common charges used to calculate your usage (allowance and any excess) are as follows;

Usage in Australia	
Excess Call Rate per Minute to fixed Lines & mobiles (charged per 60 sec Block)	\$0.10
Excess Data Rate per GB Block (upload & download counted)	\$10.00

Excess Usage 1GB Data Blocks are automatically applied to your service at a cost of \$10.00 for any usage in excess of your Monthly Data Allowance. You may elect to limit your excess usage spend in My Exetel, under Spend Treshold Management.

Excess National Data per 1MB (charged per GB Block)	\$0.01

If you restricted your use solely to Standard National Mobile Calls each of 2 minutes in duration, you could make 150 calls.

Other Information

Using Your Service Overseas

You cannot use your included Voice call minutes and SMS/MMS allowance and mobile data allowance if you are overseas. If you want to use your Exetel mobile phone plan when overseas you'll need to activate roaming if its not already on. You can check your roaming settings and turn it on/off in the My Exetel user facilities. You will be charged at our roaming rates which are significantly higher than your normal mobile voice calls, message sent & recieved and data usage (note, roaming is only available for certain countries).
